

Using the Pupil Premium and Pupil Premium Plus (PP)

The Staff at St David's C of E Primary School are committed to ensuring **all** children achieve their potential.

We are all aware of the research showing disadvantaged children often fall behind their peers, achieving lower grades throughout their education. This is known as an "attainment gap" and the purpose of the PP is to "narrow the gap". As a result of the evidence, the government introduced the Pupil Premium (PP) in April 2011. Pupil Premium is paid directly to schools.

Who is eligible for the Pupil Premium?

Ever 6 FSM

The pupil premium for 2020-21 will include pupils recorded in the January 2020 school census who are known to have been eligible for free school meals (FSM) since May 2013, as well as those first known to be eligible at January 2020.

Children adopted from care or who have left care

The pupil premium for 2020 to 2021 will include pupils recorded in the January 2020 school census and alternative provision census who were looked after by an English or Welsh local authority immediately before being adopted, or who left local authority care on a special guardianship order or child arrangements order (previously known as a residence order). These children are referred to in the terms of the grant as pupil premium plus children.

Ever 6 service child

For the purposes of these grant conditions, ever 6 service child means a pupil recorded in the January 2020 school census who was eligible for the service child premium since the January 2013 census as well as those recorded as a service child for the first time on the January 2020 school census.

Rates for eligible pupils

The PPG per pupil for 2020 to 21 is as follows:
