You no longer have to reapply as we are able to carry out an audit check from time to time on your eligibility status. However, as soon as your circumstances change, for example, if you start to receive **Working Tax Credits** or you **stop receiving any of the qualifying benefits**, you **must** notify us by phoning **0845 155 1019**. We will then inform your child(ren)'s school.

We are not informed automatically if your circumstances change and you no longer qualify for Free School Meals.

*Applications for Free School Meals are administered by Devon County Council for state-funded schools. You should apply to Devon if your child(ren) attend a Devon school - with the exception of **Colyton Grammar School** and **Bickleigh-on-Exe Primary School**, to which you must apply direct.

Devon is also responsible for Free School Meals applications for **Plymstock School**, **Coombe Dean School** and **Oreston Community Academy**. If your child attends one of these schools, you need to apply to Devon.

How do I qualify?

If you receive **any** of these benefits you will be entitled to Free School Meals:

- * Income Support (IS)
- * Employment and Support Allowance (income-related)
- * Child Tax Credit (without Working Tax Credit) and with an annual taxable income assessed by HM Revenue and Customs to be less than £16,190
- * Income-based Jobseeker's Allowance (IBJSA)
- * Guaranteed element of State Pension Credit
- * Support under Part VI of the Immigration and Asylum Act 1999

If you have recently become unemployed and are still receiving Working Tax Credits, you may still be eligible for Free School Meals for a four week period only. Please call us on **0845 155 1019** for advice.

How do I apply?

- 1. Fill out the form overleaf, including the declaration at the bottom.
- 2. Take the completed form to your child's school or email it to **freeschoolmeals@devon.gov.uk** or post it to the Admissions Team, Room L102, County Hall, Exeter EX2 4QD.
- 3. We will then enter your details into an online Eligibility Checking Service which will tell us whether or not you are eligible for Free School Meals.
- 4. We will then send you a letter with the decision, usually within 5-10 working days.
- 5. If the letter states **Authorised**, we will inform the school and your child will be able to receive Free School Meals.
- 6. If the letter states **Not Authorised**, we will inform the school and your child will not be able to receive Free School Meals. If you believe you are eligible, please call **0845 155 1019** for advice. We may need you to send us evidence that you are in receipt of a qualifying benefit.

You do not need to send evidence of your qualifying benefit(s) with this application. If we need evidence at a later date, we will contact you.
